In 1996, he started Local Island Fresh Edibles, Inc., a distributor of fresh local grown produce. Today Nalo Farms services over 120 restaurants on Oahu, Maui and Kauai and has taught farmers on Maui and Kauai to do what they do here on Oahu. In addition, they looked for other locally grown premium produce to promote and deliver to restaurants. This has resulted in such products as Hau'ula Vine-Ripened Tomatoes, Kahuku Super Sweet Corn, Kahuku Long Eggplant, Kula Baby Romaine and many other
